#### **Contract Terms and Negotiation Schedule**

The consultant for Financial Advisor is expected to negotiate an agreement for services that is acceptable to the Water Supply Corporation. If an acceptable contract cannot be negotiated, the

Water Supply Corporation may formally end negotiations and begin negotiating with the next highest qualified person or firm.

This contract is contingent upon release of funds from the Texas Water Development Board (TWDB). Any contracts awarded under this Request for Qualifications are expected to be funded in part by a loan from the TWDB. Neither the State of Texas nor any of its departments, agencies, or employees are or will be a party to the Request for Qualifications or any resulting contract. Request for Qualifications are issued in accordance with Section 2254 of the Texas Government Code (Professional Services Act).
